§ 16 Subject-specific requirements for dissertation projects in the Department of Linguistics:

Programme of study:

In addition to an original research project, culminating in a dissertation, the doctoral programme specifically requires that candidates gain in-depth exposure to topics outside their immediate field of research, as well as experience in teaching and presentation of research. Modularization allows the accumulation of internationally transferable ETCS credits.

The programme of study comprises four modules, each of which contains a number of study units. In addition, doctoral students are expected to participate in the departmental research colloquium, for which, however, no credits are awarded.

Module 1: Compulsory study units

Each of the four study units listed below must be completed to obtain the respective credits, yielding 21 ECTS credits for this module.
