ORIGINAL COURSE DESCRIPTION

Der Kurs beschäftigt sich mit Possessivkonstruktionen in verschiedenen Sprachstufen und im Dialekt im Vergleich zum heutigen Standarddeutschen, wobei neben den diachronen Veränderungen auch verschiedene syntaktische Ansätze zum Thema erörtert werden. The course addresses possessive constructions in different stages of German as well as in dialects comparing them to modern standard German. Besides diachronic changes we will also discuss different syntactic approaches to the topic.
